#### VIII. MANAGER'S REPORT

Broadstone 1, 2, and 4 has had approximately 10 median monuments 3 of which have been hit by cars, and have been repaired or in the process of being repaired.

LED Streetlight Conversions – Member Marceau asked in last months meeting what would the cost be if all streetlights were converted to LED. The saving to switch from HPS to LED we save about 56% of \$189,293.00 in utility bills for SMUD we would have saved \$106,004.00, our bill for SMUD would have been approximately \$83,289.00.

Allen Brown (ARCN) – Member Brown discussed the waterfall work is in progress, the lights all come on but they do not stay consistently on sometimes a few come on and then go off.
