The Master Tree List helps people find the right tree type for their location. If you are going to dig, be sure to call 811, call before you dig. Be mindful of trees that require a lot of water. The requirement for City of Folsom is one "street tree" on your lot, if you are a corner lot you must have 2 "street trees". To work on "street tree" you will need a permit from the City of Folsom. If you notice "street trees" removed, you can contact the City Arborist.

Edward Myers (Broadstone 1,2,4) – Member Myers new replacement trees on Rathbone Circle look great. He is interested in replacing the mulch in his district. Manager Perras stated he has spoken to solid waste and they will be reaching out to start the process.

Tim O' Leary (Prairie Oaks) – Member O'Leary the fences are going up on Grover Road and they look good. Manager Perras said they have a meeting with the Landscape Architect to get a preliminary design.

David Weizer (ARCN #2) – Member Brown there are some junipers on Alabaster Point that seem to have been treated with weed killer and look partially dead. Manager Perras stated the Bright View will be coming to look at. Member Brown wanted to make sure when the waterfall is repaired they do repair the landscaping around the area.

Allen Brown (ARCN) – Member Brown wanted to mention that the strip along the waterfall will be considered in the landscape plan. The west side of the waterfall has a pine tree that has died.

Benjamin Mattocks (Prospect Ridge) – Member Mattocks has put in a “See -Click-Fix” for a plant bed that has eroded and hasn't seen any action on this. Manage Perras will send someone out to look at. Near the tree that was replaced there is another tree that seems dead and needs to be looked at.
