2019 Liability Insurance

Evidence of liability insurance with a minimum amount of \$1,000,000 per occurrence must be provided for all events. Organizations who have their own commercial general liability insurance can provide a policy certificate and a separate endorsement (form CG 20 10) or equivalent, as approved by the City Attorney, naming the City of Folsom as an additionally insured party. A sample of the required endorsement is attached for your review. Please reference this form when requesting coverage from your insurance agent. Policy certificates without the required endorsement will not meet the insurance requirements.

If you or your group elects to purchase the required liability insurance through the Community Center Office, the following information will help you choose the correct coverage and premium for your event. The special event liability insurance will be provided through Diversified Risk Insurance Brokers. The premium for your event will be based on the hazard classification and attendance. Liquor liability coverage is included in this policy unless it is being sold. Sale of alcohol to guests requires an additional premium. The chart below lists the premium charges for events held in 2018 for hazard class I and hazard class II, and the different attendance categories.
