VIII. INPUT FROM COMMITTEE MEMBERS ON L&L DISTRICTS

Josh Baker (Cobble Hills Ridge / Reflections II) – Member Baker reported no issues in his district.

Tim O' Leary (Prairie Oaks) – Member O'Leary was asking about the timeline for the service from Bright View design. Manager Perras advised that as soon as he receives the final design, he will provide Member O'Leary a copy of the design.

Joanna Stanfield (Sierra Estates) – Member Stanfield nothing to report.

Patty Soulsby (Blue Ravine Oaks) – Member Soulsby stated the house on 145 Timson Drive has sidewalk damage and asked if the inspector has been notified to fix the damage. Manager Perras will reach back out to the Construction Inspector to see what the status is. The Crepe Myrtle at 103 Framingham Way needs to have the black straps moved up on the support stakes. There are some weeds in the city well that need to be removed.

Edward Myers (Broadstone 1,2,4) Member Myers reporting goats in his area. Also reported an issue to See Click Fix, there are weeds on Rathbone Circle and Halidon Way, Supervisor Larson advised it is being addressed. Manager Perras asked if the Sacramento Tree Foundation had reached out to him, he stated not at this time.

Allen Brown (ARCN) – Member Brown thanked Manager Perras for removing the dead vegetation from Mystic Hills. Member Brown asked about the renovation in that area, Supervisor Larson stated that if they removed the vegetation, they have most likely started the project. Member Brown asked about the front landscaping in front of the waterfall and is wondering when the work will be started. Manager Perras advised that they still have not seen the final plan and are waiting for the landscape architect to submit the final plans.

David Weizer (ARCN #2) – Member Weizer was asking about the culvert replacement. Manager Perras stated it should be completed by the end of summer. Manager Perras also mentioned the other drainage issue in American River Canyon will be having a kickoff meeting between the storm water engineer, Folsom Public Works Department, and San Juan Water District on June 29, 2023. Member Weizer had a question regarding the large evergreens on Alabaster Point that had root rot and have they been treated, Supervisor Larson has asked for a proposal of replacement for anything that is to far gone to replace and is waiting for Bright View to respond. Member Brown mentioned that this quite a bit of blackberry bushes coming in between the rosemary. Manger Larson took notes and will address.

Benjamin Mattocks (Prospect Ridge) - Member Mattocks nothing to report.

Ajit Natu (Willow Springs) – Member Natu stated there is a vacant area at the corner of Riley Street and McAdoo Drive are they planning to develop that area? Manager Perras stated it is a future phase of Livermore Park.
