Director Gonzalez gave a preview of the PowerPoint presentation that was presented to the Council regarding budget priorities for the department. Ongoing funding is needed. Spoke on the development of an updated Park Renovation Plan as well as her efforts working to develop and adopt a Deferred Maintenance Program to help as well. as the Development of Trail Maintenance & Hazard Tree mitigation plans.

- B. Ladder Fuel / Weed Abatement – Jamison Larson, Municipal Landscape Services Supervisor

Jamison gave an overview of the program and their practices. This is the first time in 20 years the program has been activated. The program requires staff to perform regular inspections, and field public inquiries. The use of the Fire Hazard Rating System to evaluate parcels. The goal of the program is to limit the spread of any ground or surface fires into tree canopies creating crown fires. To date 38% of the project has been completed.

The City of Folsom adopted the Strategic Plan FY 2023-24 through FY 2027-28.

The Parks & Recreation Department is dedicated to supporting the goals and initiatives of the Strategic Plan. The goals identified by the City Council include Financial Stability, Public Safety and Infrastructure, Economic and Community Development, and Organization Effectiveness.

Goal A: Financial Stability and Sustainability

Support fiscal health through long-term planning, cost control, heightened efficiency, increased revenue, and cost recovery.

- Staff presented the Parks & Recreation Department's top priority needs for additional funding, and CIP updates for FY 2024-25 to the budget committee.
- Spring Sea Squad Swim School lessons began March 25. More than 1,250 participants have already enrolled in our spring and summer lessons, filling 89% of our capacity.
- The Folsom City Zoo Sanctuary held its popular Jr. Zookeeper Camp during spring break, welcoming 21 participants. Campers enjoyed a variety of hands-on activities, including cleaning animal exhibits, preparing bear diets, and crafting enrichment for the animals.
- Municipal Landscape Division staff held a Prop. 218 informational meeting March 13 for Natoma Station Landscaping and Lighting District property owners. The response was overwhelmingly positive, with attendees expressing strong support for increasing their property assessment to fund higher levels of maintenance and address deferred maintenance and lifecycle replacements.

Goal B: Public Safety and Infrastructure

Enhance provision of public safety resources, invest in technological solutions, and maintain, repair, and improve public facilities and infrastructure.

- On March 1, the ballfields opened to several of the Folsom-based community youth sports leagues for their spring season. Parks Maintenance and Sports Division staff renovated 22 ballfields during the winter to have them ready.
- The Steve Miklos Aquatic Center held its first Ellis & Associates lifeguard training session March 25-28 with 15 participants enrolled.
- The Steve Miklos Aquatic Center underwent the first of its four annual operational safety audits March 23. The facility and staff received the highest possible score of “exceeding industry standards” based on emergency response preparedness, administrative organization, and staff professionalism. Kudos to the outstanding team members who participated in the audit: Scott Seeba, Claire Swagerty, Michael Long, Joe Carrera, Conner Reid, Gunnar Kroencke, and Mathew Kersey.
- The Folsom City Zoo Sanctuary received its new electric gator.
- Construction of Prospector Park continues. As the weather improves, more construction activity will resume, with grading of the parking lot being completed. Class II aggregate base is being installed in the parking lot and the formwork for concrete curbs is starting. Pathway light pole footing rebar cages are complete, and footings are being poured. The final section of the 6-inch-diameter irrigation non-potable mainline was installed and pressure-tested.
- Design development and the CEQA process are continuing for Benevento Family Park. It is anticipated the construction documentation will start this summer.
- Project submittals for the Johnny Cash Trail Art Experience Cash’s Pick No. 1 are being reviewed and a construction kick-off meeting was held in March. The custom 20-foot cast iron record deck shop drawings were received for review and approval.

Goal B: Public Safety and Infrastructure (*continued*)

- The Livermore Community Park Phase 5A project continues. The Design Development Package was submitted in February and is being reviewed.
- The Municipal Landscape Division's annual weed abatement for fire hazard mitigation has started, and 107 acres of grassland in the Folsom Plan Area are completed. North of 50 grazing and manual weed abatement will begin in April.
- Parks & Facilities attended a meeting hosted by the Sacramento Midtown Association to learn more about the "Safe & Clean" program that provides graffiti, biohazard, litter, debris removal, and power washing services to Midtown Sacramento. Judy Collinsworth plans to connect with FHDA members to see if they want to start a similar program in the Historic District.
- Facilities Services continues to oversee the City Hall HVAC project. The installation of the first-floor VAV units is nearly complete.
- After receiving the final parts, we are proud to announce that the iconic Folsom Clock Tower is now fully operational.

Goal C: Economic and Community Development

Promote effective use of existing amenities and resources to create future opportunities that enrich the community.

- Folsom hosted two youth softball tournaments at Lembi and Kemp parks for two weekends. These tournaments included teams from Oregon, Nevada, and Canada.
- Staff met with two prospective buyers for the Folsom Valley Railway which operates out of Folsom City Lions Park, to review the concessionaire agreements and ensure a seamless transition between owners.
- Folsom Comic-Con was a large-scale rental at the Folsom Community Center March 10. The event was featured on KMAX Channel 31's Good Day Sacramento morning news program.
- The Youth Services Division launched "Destination Recreation," a rebranded summer camp program. The camp will operate out of Theodore Judah Elementary School beginning June 3. This reimagined camp program embodies our commitment to offering a dynamic and engaging recreational experience by promoting active participation in sports, STEAM, and outdoor adventures. We remain focused on creating memorable moments filled with laughter, fun, and friendship while nurturing a love for recreation and exploration.
- The Senior Center held its annual St. Patrick's Day Shamrock Shindig March 15 with a lively crowd in attendance.
- The monumental task of stuffing 10,000+ eggs with candy and prize slips was completed the evening of March 27 by 265 industrious community volunteers. The eggs are used at the free Festival of Eggs community event March 30.
- The Folsom City Zoo Sanctuary restarted their Animal Interpreter program which had been on hold during winter. Volunteer docents bring outreach animals out on weekends for educational talks with guests.
- The summer edition of the Rec Guide was formatted and reviewed this month. The 56-page guide includes summer camps, special events, and programs for all ages. The guide posts on the city website April 10 and programs open for registration April 17. Residents will receive their copy in the mail mid-April.

Goal D: Organization Effectiveness

Build strong connections and support for the community and employees through a commitment to local government best practices and employee development, support, and retention to meet community needs.

- Staff met with NeoGov to discuss the feasibility of adding additional modules to streamline and enhance the new-hire onboarding process.
- Staff met with Sacramento Splash March 5 to discuss environmental and nature programming that can be conducted in a contracted partnership at the Hinkle Creek Nature Area.
- The Steve Miklos Aquatic Center held the first set of group interviews for the summer season and offered 22 positions.
- The Folsom City Zoo Sanctuary successfully passed their USDA Three Year Cohort Re-licensing inspection. This accomplishment was made possible through the collaborative efforts of the entire department.
- The Park Maintenance Division has implemented new time maintenance standards for our 34 parks. These guidelines provide staff with clear direction to effectively prioritize tasks and assistance in identifying labor costs per park, ensuring optimal maintenance to maintain our amenities and assets.

Parks & Recreation Staffing

- Zach Perras, Municipal Landscape Manager, accepted the Parks Manager position with El Dorado County; his last day was March 20. A recruitment to backfill his position will be posted soon.
- Applications for the new Recreation Coordinator II closed this month. Seventeen applicants met the minimum qualifications for the position and interviews are slated to begin soon.

Department Highlights and Summary

- On March 13, the California Park & Recreation Society (CPRS) presented Folsom's Community Service Day with the Recreation & Community Program Award. Staff attended this event along with Chair Wallace. The award recognized the Folsom Community Service Day, from their 19-county geographic districts, for providing the largest day of volunteerism in the City of Folsom. The city was recognized for accomplishing over 100 projects and giving over 2,000 people the opportunity to volunteer. Since its inception 10 years ago, Folsom Community Service Day has involved more than 20,000 volunteers; 930+ projects have been completed; 570 exterior home repairs have been made through the Neighbors Helping Seniors program; 590,000+ pounds of food have been collected for the Twin Lakes Food Bank; thousands of care packages assembled and sent to active-duty military members; and thousands of items donated to locate nonprofits including bikes, eyeglasses, shelter pet supplies, and more.
- The city hosted the Folsom Community Service Day Steering Committee kick-off meeting March 21. The committee reviewed roles and responsibilities as it prepares for the 11th annual event to be held September 21. A variety of sponsorship opportunities are currently available.
- The Festival of Eggs will be held from 8 to 11 a.m. March 30 at Lembi Park. The annual springtime event includes all the popular elements: a pancake breakfast (purchase onsite), free kiddie carnival games hosted by the Folsom Teen Council, entertainment, and vendor displays.
- The city's Earth Day celebration takes place April 20. This free family-friendly event starts at 9 a.m. with volunteer opportunities including creek and trail clean-up, tree planting, and trail maintenance.
- The summer edition of the Rec Guide is in the final development stages. Staff are excited for residents to explore the carefully planned summer activities for family members to enjoy. The digital guide is available on the city's website April 10, and registration opens April 17. Check your mailboxes for the printed copy of the guide mid-April.
