The City Arborist will take final action on the application and will approve, conditionally approve, or deny the tree removal proposal based upon required findings outlined in Folsom Municipal Code 12.16.80. The decision letter regarding the determination of the application will also be posted at the abovementioned website. Interested persons are invited to express their opinions. If you challenge the determination of the City Arborist, you may file an appeal to the City Clerk’s office within 10 calendar days following the decision. Appeal applications can be obtained at the City Clerk’s office, located on the second floor in City Hall, 50 Natoma Street, Folsom, California 95630.
