RECOGNITION AWARD PROGRAM WINNERS

BACKGROUND

The Arts Achievement Recognition Program was developed in 2004 by the Arts and Culture Commission (ACC) to increase awareness and recognition of outstanding arts individuals and organizations in Folsom. There are two award categories that are available for submission. The first is the Folsom City Council Resolution of Commendation which is awarded to larger groups or organizations that meet the Arts Achievement award criteria. The second is the Folsom Arts and Culture Commission Certificate of Recognition which is appropriate for individuals or smaller organizations that meet the Arts Achievement award criteria.

DISCUSSION

Staff opened the recognition awards following commission approval on August 15, 2024 and closed it on Friday, November 1, 2024. At the time of closing, we received 3 nominations for the Arts Achievement Recognition Awards.

The first nomination was submitted for Tiffany Ramirez, an individual and founder and creative director of the non-profit, Artisan Mind. She provides creative experiences that support people living with physical and cognitive challenges. (Folsom Arts and Culture Commission Certificate of Recognition)

The second nomination was submitted by the Folsom Arts Association, a non-profit membership organization founded in 2003 and comprised of over 200 members dedicated to visual arts. Their purpose is to promote the appreciation of and participation of visual arts. (Folsom City Council Resolution of Commendation)

The third nomination was submitted for Hasitha Mallavaram, an individual for Visual Arts with two submissions of artwork of Buddha Art and Ardhanarishvara Art. (Folsom Arts and Culture Commission Certificate of Recognition)



• The 6th Annual Folsom Glass Pumpkin Patch took place on October 12 and 13 with over 6,000 visitors attending the two-day event. Revenue generated from this event help offset costs at the art center for art education and upgrades to aging program supplies and materials.





- The 32nd Folsom Renaissance Faire returned to Rodeo Park and City Lions Park on September 28-29. Roughly 4,000 visitors attended daily the many vendors and events that were held on the grounds.
- Folsom Community Service Day was held on Saturday, September 21 with over 2,000 volunteers contributing over 9,000 volunteer service hours to beautify the community. Several projects at city properties were completed as well as over 28 tons of food donated to Twin Lakes Food Bank. Our very own Commissioner

Vander Veen completed a restoration and beautification project for the railroad. Additionally, Commissioner Cantu was out and about taking pictures of the great day. Thank you both very much!

Tiffany Paige Ramirez is the Founder and Creative Director of the non-profit, Artisan Mind. She provides creative experiences that support people living with physical and cognitive challenges (website: http://www.artisanmind.org).

Tiffany lost her grandfather to Alzheimer's, which influenced her decision to pursue starting a creative arts program. Tiffany started pursuing her passion to bring the healing properties of art and imagination to lives of people living with dementia.

Through partnership with ARTZ: Artists for Alzheimer's and the I'm Still Here Foundation, Tiffany launched ARTZ Sacramento in 2011 and then founded Artisan Mind in 2014. She is responsible for initiating an art liaison program for hospice care and developing numerous person-centered life enrichment programs throughout Northern California, including Folsom.

Tiffany believes that one of the great needs in the world is Truth and Love. Tiffany is committed to raising awareness of the value of creativity and faith for people living with cognitive challenges among memory care communities, care partners, support groups, and spiritual organizations, especially in Folsom. Her work has been recognized by the County of Sacramento with the Hero of Human Services Award. Artisan Mind serves numerous individuals and retirement/memory care communities in Folsom, including Eskaton, Oakmont, and Prairie Landing.

Overview of FAA Activities

- FAA hosts monthly art demonstrations by regional artists that are open to FAA members and the general public. These demos cover a variety of mediums, reflective of the diversity of our membership. This past year, for example, we have had demos of thrown pottery, watercolor, acrylics, encaustic, oil, and gouache.
- We also conduct workshops at Folsom Lake College, again open to members and the general public [over age 18]. This year we're conducting 5 art workshops, 2 in watercolor, and 3 in oil or acrylics.
- We provide support to Gallery 48 Natoma a City of Folsom treasure. FAA helps hang art shows and staffs the artist receptions whenever a new Exhibit is hung in the Gallery.
- FAA sponsors member art shows at Gallery 48 Natoma and The Harris Center for the Arts. FAA pays for the judging of these shows, and awards cash prizes to the winning artists.
- Every other year, FAA sponsors an amateur photography contest open to the community at large. Children and adults are allowed to participate; participating artists are allowed to hang their photo art in the Community Gallery at Gallery 48 Natoma; and cash prizes are awarded by Folsom Arts Association.
- In addition to these direct activities, FAA promotes and many of its members participate in other locally-sponsored art and community benefit activities e.g.:
 - This past year, FAA members have painted and donated tiny artworks to the "Free Little Art Gallery" at Folsom Lake College.
 - Also, around the winter holiday time, FAA members donate gift items of all kinds to needy families in the Folsom area. In addition to filling large grocerybags with donated gifts, members gather at Gallery 48 Natoma to decorate the bags in holiday themes, and some help deliver those bags to the receiving families.

Types of Arts FAA Members Create

- Our member artists span a wide variety of mediums: Acrylics, Alcohol Inks, Ceramics, Drawing, Glass, Jewelry, Mixed Media, Oil, Pastels, Photography, Resin, Sculpture, Watercolor, Woodworking. For practical reasons, monthly demos generally feature two-dimensional mediums for which equipment and supplies can be easily transported.
- FAA is currently working on organizing a sub-group of artists who work in ceramics and pottery, and hopes to offer demonstrations and workshops in those mediums.
